1. Apologies for absence

2. Minutes of the previous Road Reps Committee Meeting

HHPC453:03.04.20 Due to this meeting being the first of the newly formed Road Reps Committee it was recognised that there were no previous minutes.

3. Emergency decisions taken since the last meeting

4. Finance

HHPC455:03.04.20 The Chairman, Cllr G. Crozer, spoke to advise that on behalf of the Parish Council he was providing the committee with a £1,000 grant.

Cllr M. Stone, also spoke to inform the members that following an email from Rev S. Gwilt, that she understood All Saints Church in High Halstow had pledged an additional £1,000 to the Road Reps Committee funds.

Cllr M. Stone spoke to air her concerns in regards to the lack of PPE equipment, which she felt the volunteers needed. She asked the committee for permission to purchase latex gloves, face masks and antiseptic spray.

The members unanimously agreed that PPE equipment should be purchased without permission, as it was deemed an essential. A discussion ensued as to where the committee could source potential PPE equipment, as it was acknowledged that PPE equipment was in short supply everywhere presently.

Cllr G. Crozer spoke to acknowledge that a chemist, who lived in the village, had already donated 25I of antiseptic liquid free of charge.

5. DBS Checks

It was decided that DBS checks were not needed, however all volunteers would need to provide proof of their identity and evidence of their address to ensure they were registered as living in the village against the Parish electoral role.
